Ongoing Sub-committee Activities / Charges & Strategies	<p>The sub-committee undertakes the following activities:</p> <ul style="list-style-type: none"> • Develop education, tools, and resources for LTC professionals specific to Assisted Living settings. • Create and maintain collaborative partnerships to best meet the needs of Assisted Living stakeholders, including patients, families, staff, and volunteers. • Contribute Assisted Living guidance and best practices to JAMDA through the development of editorials, white papers, and Pragmatic Innovation Section topics.
Roles and Responsibilities	<p>Chair</p> <ul style="list-style-type: none"> • Help structure agenda for meetings. • Run an effective meeting to ensure involvement of members and the advancement of activities and charges. • Communication with the Board liaison before and after each Board meeting to share updates from the Sub-committee and to hear about new Board initiatives. Report back to the full Sub-committee on each discussion with the Board liaison. • Identify, mentor, and groom the next Chair. • Assist with structure and selection of members. <p>Vice Chair</p> <ul style="list-style-type: none"> • Support the Chair to ensure responsibilities are met in a timely manner. • Serve as interim Chair in the absence of the Chair. • Recommend individuals to serve as the next Vice Chair. • Ascend to the position of Chair. <p>Members</p> <ul style="list-style-type: none"> • Be prepared and actively participate in all conference calls and meetings. • Work on projects as delegated by the Chair.
Expected Commitment	<p>The committee meets quarterly via conference call. Members are expected to review all agenda/materials prior to each meeting, attend the conference calls as scheduled.</p> <p>The estimated monthly time commitment is 1-5 hours.</p>

Sub-committee Composition	The Assisted Living Subcommittee is comprised of medical directors, physicians, nurses, and academicians
Sub-committee Terms	All sub-committee members serve a two (2) year term and are eligible for reappointment once. Terms run May to April. The Chair and Vice Chair each serve a two-year term.
Selection/ Appointment	Members are appointed by the President with input from the Chair. The Committee Chair and/or Vice Chair is recommended by the outgoing Chair and appointed by the President.
